Objectives :-








1. To Promote and foster Interaction between alumni and a'ma mater.
2. To make available the expertise and experience of the alumni for the development of research and educational activities of the college.
3. Establishing continuous and effective communication among the alumni community.
4. To improve the facilities and infrastructure of the college with the help of active participation of the alumni.
5. To exchange professional knowledge, organize conference, seminar and workshops.
6. To organise reunion on the college campus or other places.
7. To promote and support research and academic activities of the institute.
8. To award incentive/prizes for outstanding contribution of scholars.
9. To raise and administer for the association (contribution/collection).

Membership :-

1. Membership of the association is open to all former students of the college.
2. Application for membership shall be made in the prescribed form.
3. All the members of Association will form general body of the Association.
4. The membership in the Association shall be of the following categories:
 1. 'Members' means all the former students of the college who has become a member by filling the Membership form.
 2. 'Honorary members' means the teaching staff of the college.
 3. Every member other than honorary member shall have a right to vote in the meeting of the Association.
 4. The Association shall maintain a register of members and it shall be open to inspection by all members.
 5. A member may resign from the society with 15 days notice.

Membership Fee :-

1. Membership fee for those who has completed 10 year after leaving the college is Rs. 500/- only for one time.
2. Other than above membership fee is Rs. 100/- for one time.

Duties of the General Body :-

1. To set guidelines for the executive body so as to achieve aims and objectives of the Association.
2. To elect office bearers and members of the executive committee.

General body meeting:-

All the member of the Association constitute the General Body and the general body meeting of the member of the Association shall be held annually to transact the following business-

1. Approval of audited balance sheet and income/expenditure account of the association.
2. Approval of the secretary's report.
3. Election of members of the executive Committee when such election is due.
4. Suggestion and recommendation of the members regarding the policies of the Association.
5. Consideration of matters as approved by the President.
6. Fifty percent of the members of the association may in writing request for convening a special General Body Meeting to consider specific issues.
7. Quorum for any General Body meeting shall be 25% of total members of the Association. If the quorum is not completed meeting shall be withheld for 15 minutes and then resumed.

Governing Body(Executive Members)

1. The Association shall be governed by a Body of Executive Committee consisting of 4 members elected by the General Body. They being one President, two Vice Presidents, One Secretary, two Joint Secretaries, one Treasurer and 04 Executive Members.
2. The members of the Executive Committee shall be elected by the members in the General Body meeting.
3. The members elected shall hold office for a period of three years.
4. The members of the Executive Committee shall not be entitled for any remuneration.
5. The Executive Committee shall meet at least once in three months
6. The quorum for Executive Committee meeting shall be 1/3 of the total members.
7. The Executive Committee shall be convened by the secretary
8. The proceeding of the Executive Committee meeting shall be recorded in a register.
9. A person who is not a member of the General Body shall not be elected to the executive committee.
10. Any vacancy in the Executive Committee arising out of death, insanity or resignation may be filled up by the Association.

Duties Of The Governing Body:

A. Duties of the President

The president shall preside over all the meetings of the association

B. Duties of the Secretary

The secretary shall convene the meeting with the consent of the President. He/she shall be custodian of all the records and properties (if any) and shall discharge all administrative duties approved by the Association.

C. Duties of the Vice President

In the absence of the President the Vice President shall preside over all the meetings of the Association. In the absence of the President and Vice President, the President of the day shall be elected from amongst the members

D. Duties of the Joint Secretary

In the absence of the Secretary the Joint Secretary shall discharge all the duties assigned to the Secretary.

E. Duties of the Treasure

The Treasurer is responsible to maintain accounts of the Association and audit in proper manner.

F. Financial Limit

Bank Account of association will be operated jointly by signatures of president and treasurer with the financial limit of Rs 1.00.000 (One Lakh Only).

Powers of the association -

1. The affairs and properties of the Association shall be vested in the Executive Committee and shall be subject to the supervision and control of the General Body.
2. The Executive Committee shall have powers to incur necessary expenditure for managing and carrying out the objective of the Association.
3. The Executive Committee shall maintain all book of accounts.
4. The Association shall have powers to borrow funds ; receive donations to raise funds according to the requirements of the Association.
5. The Association shall cause the accounts to be audited annually.
6. Every transaction of the Association shall be decided in the meeting of the Executive Committee.
7. Any vacancy in the Executive Committee shall not affect the validity of the proceedings of the Executive Committee if quorum is there.

Funds of the association -

1. The funds of the association shall be those funds which are brought into the accounts of the Association.
2. Record of assets of the Association such as properties (movable and immovable) etc. shall be maintained in a Register of Assets. The register shall show the nature of the property, its value and the nature of the right of the Association.

Dissolution:

No confidence motion : Each and every member has the right to bring a no-confidence motion against Governing Body (Body of the Executive Committee), provided such notice for is signed by minimum of 50% of total members of the Association.

Records to be kept :

1. By-laws of the General Body Alumni Association.
2. Minutes of the Executive Committee meetings.
3. Record of members.
4. Accounts of the Association.
