



01 .IDP Introduction

This college was established in the year 1958 under the umbrella of Saraswati Shikshan Samiti. Chairman of the committee Shri Kuldeep Sahay, Secretary late Mr. Sharda Prasad Verma, Member, Mr. Mahavir Sharma, Mr. Lakheshwar Paliwal and Pt. Shiv Prasad Sharma were there. In the year 1975, when the college came under government, it was renamed as Government TCL Post Graduation College, Janjgir in the memory of Barrister Thakur Chhedilal, Freedom Fighter. Mr. Satya Sahai Srivastava was the first principal of the college. Initially it consisted of art classes. It came into existence in the year 1983 as Law College. Presently post graduate classes are being conducted in Arts, Commerce, Science, Law & Computer Science.

The naming history of Janjgir is named after Jajwalya Dev, a Haihaywanshi Kalchuri descendent of the famous Ratanpur state. Jajvalyadev (1090-1120) established the city of Janjgir in his own name. Vishnu temple near Bhima talab is famous which is made of Stone bricks. The pride of the dynasty gradually decreased. The Ratanpur state came under the control of the British after being under the Marathas. Finally, independent India emerged, then came the period of sunrise of education. Principal of Shiv Bhagwan Rameshwar Lal College, Bilaspur late. With the inspiration of Anandi Lal Pandey, a private college was established in 1958 under Saraswati Shikshan Samiti. This college is moving in the direction of intellectual development by setting the steps of progressive progress.

According to honourable Shiv Prasad Sharma, advocate and former MLA, “The tiny light beam of education established by Saraswati Shikshan Samiti is lighting up the area in the form of a bright light today”. At present it is a leading College in Janjgir-Champa district. This institution is affiliated to Shaheed Nand Kumar Patel University, Raigarh and is registered with the University Grant Commission, as a result of which the college gets all the facilities under the scheme of the University Grant Commission, New Delhi. All extra-curricular activities and functions are organized as directed by the University and the Government. 17 colleges of this district conduct their work under the direction of leading college Janjgir. This is truly making this famous saying of Sanskrit “**Vidya Vindate Amritam**” fruitful.

This first building of this institution was situated near the Kutchery Chowk, Janjgir and was shifted around twenty five years ago to its present location in Khokhra, Janjgir. The tagline of this institution is ‘Vidya Vindate Amritam’ i.e. Vidya se manushya jiwan ka amrit prapt karta hai (learning bestows thee nectar of life). The tagline of college signifies its philosophical vision and the output it plans to share in the society logging to excel in the field of higher education. The program being offered presently are in the stream of Arts, Sciences, Commerce, Law & Computer Science. The vision of the institution is to enlighten, empower and enable the learners and ensure that the students are properly facilitated for qualitative improvement. So the first priority is to build sufficient infrastructure like well equipped smart class rooms, computer Labs, Auditorium, playground, central library with internet facilities, full fledged laboratories, research and innovation centers, music and dancing room to promote Indigenous art and culture of the region, Historical Museum to preserve the cultural heritage of Janjgir-champa.

B. SWOC Analysis Summary

Being the lead institution there is a sufficient strength of teaching faculty with many from other parts of the country. More than 50% of the faculties are PhDs in their respective fields of study, 8 teachers recognised as research guides by the affiliating university and there are 2 research centres. Programmes are offered in the four streams of study i.e. Arts, Sciences, Commerce and Law. The college serves the society in the field of higher education and through various extension activities by NSS, NCC, Red Cross, Science Club, Red Ribbon Club, Legal Aid Clinic etc. Maximum faculty members are using ICT for effective teaching-learning process.

Institutional Weakness Various weaknesses of this institution include- Students from different backgrounds needs special attention and mentoring with extra effort. There is a dearth of permanent faculty in some of the disciplines which in many ways affects the teaching learning process. The less awareness of the lab assistants and lab technicians about ICT acts as stumble block in the qualitative teaching practice. Insufficient sanctioned posts for Lab Technicians.

Institutional Opportunity The institution is in the process of improving its infrastructural needs including the smart classrooms and ICT facilities. The library facilities are also being increased with the addition of more journals including online journals and more e-resources. Students are full of caliber and need more objective guidance and focus towards career-oriented goals. More law students are being sent for internship to the district court and high court and more results can be expected in various competitive examinations. The institution can serve the society in an increased manner by providing more placements and societal outreach and extension tasks.

Institutional Challenge The College is lacking in faculties and also the benefits of Associate Professors and Professorship in the field of higher education and research activities. The diversity of students from different strata of society pose challenges in the form of slow learners and lack of communicative skills which requires to be taken extra care of by putting in extra efforts in this respect. Students from very distant places have attendance problems at times though we have separate girls' hostel but facility for boy students is still lacking.

Student Centric Teaching Learning Methods-

It is the prime objective of any institution of world rankings or which aspires to be of that repute to adopt the system of imparting knowledge to the students by adopting various student centric methods. The experiential learning, participative learning and problem solving methodologies are also part of those initiatives. This Institution also takes into account this very purpose and also plans for adopting these measures. In the field of science study, arts, commerce and legal studies there are systems which gives experience to the students in the fields of study, they participate in laboratories and moot courts to learn various nuances of science and law. Problem solving techniques are also adopted in the teachings of various science courses, arts, humanities, commerce and in legal studies also students are given case law study and they participate in moot courts to solve various civil and criminal cases. Problem solving methodologies are also adopted by different departments. Through this very process different tasks are given to the students and various solutions are discussed by them. This is a regular practice in the science stream, arts, commerce and law streams. All of the student centric methods act as a futuristic result oriented step. It certainly changes the present and future of the students. Experiential learning- Practical approach is adopted in all the disciplines and programmes of study. Many programmes consist of weekly seminars on different topics to give the students practical and experiential learning. The students are given opportunity of presenting various topics of their choice through this process. Participative learning- This technique is also adopted in many programmes of study where students discuss topics in groups, they also do case studies, participate in various other curricular and extra-curricular extension activities. Students also study through their study tours and field visits through various projects. These participative process of learning advances their learning levels. Various workshops and seminars are organized by the institution and departments for the students to have more experience and they can also participate through paper presentation etc. Students are also having access to departmental libraries and main library of the college in which they can avail innumerable e learning resources for enhancing their experiences of the topic.

Catering the status of Slow learners & Advance Learners-

The Institution has adopted a mechanism to assess the learning levels of all the students in the respective departments. The departments categorise their students and try to assess the learning levels of the students. They are categorised as advance learners and slow learners on the basis of various diverse factors. A record in this regard is maintained by the teachers and accordingly by the departments to further assist them in enhancing their learning skills. The problems students are facing in the field of learning and other problems if any are recorded by the concerned teachers and suitable advice is given so that they can get some boost in their learning and get sure and certain success in their academic as well as professional lives. The steps are taken by the teachers for both the advance and slow learners separately so that the purpose of the scheme is fully served. The students are admitted on merit in most of the departments. The closure of admission process is followed by the commencement of the classes. The internal assessment is done and based on their teachers' experiences their levels are assessed in daily classes and interaction and also on the basis of their previous class results. Previous class results are also made basis of the categorization. List of slow learners are maintained, names not often disclosed to the students. Teachers cum counsellors try to know the nature of their problems and then they try to give their valuable suggestions and ways and measures to overcome them. The ultimate aim thereby to enhance the mostly practical knowledge of

the subjects and ultimately to improve their performance in the examinations and also to prepare them to be ready for fulfilling their career-oriented goals. Extra classes are also conducted as per the requirements of the students. Such students are also assisted in the revision of commonly chosen special topics. For advance learners various steps are taken one of them being the noting down of their ambitions, various competitive examinations are also suggested according to their ambitions and calibre. They are specially guided towards higher education like research work, post doctorate, various top competitive examinations of the country and the state. Scientific temperament is also inculcated to those career in the field of research and development. Their fast and sure success is ascertained which can make their life successful sooner than later and it also gives boost to the institutional academic environment. These types of students are also assisted in their studies by offering them extra classes, revision of crucial topics etc. Motivational classes are also conducted by counsellors. Apart from the use of ICT students are provided additional study materials, they are guided to other study resources, online resources of national and international level and value and often career counselling are also conducted

6. ACTION PLAN (PLANING AND EXECUTION STRATEGY)

1. **Improving employability of graduates:** It is the right time when even the UGC is feeling it quite necessary to devise some sort of course of study to substitute the present existing traditional degrees with those having some features of employability. Though it will not at all be wise enough to totally replace the traditional degrees but if an option is given to the students to choose from certain options of traditional degrees and those related to various professions i.e., other vocational degrees. The present 4 years degree course started by the DU is even the better one where one gets the traditional degrees with certain vocational or employment-oriented courses in the final year. We are of the opinion that the said 4 years degree course are good as having vocational orientation. Apart from the said degree course which is still in the nature of a pilot project being implemented for the very first time by the DU, we at our institution hereby propose to open certain other vocation oriented short term certificate or diploma courses. Ours is an area having highest population of SCs and OBCs having less education and low employability therefore we may propose the said kind of courses in the nature of tailoring, beautician, typing, horticulture etc. Such courses along with the graduate courses would definitely increase the employability of the pass out students.
2. **Increased learning outcomes of the students:** For increasing the learning outcomes of the students of the region the government is already having a very attractive scheme of providing scholarships for the students from different underprivileged and marginalized sections of the society. Apart from this the employability of the course work is a must which can certainly attract students in more numbers.
3. **Obtaining autonomous institution status within 2 years:** It is based on UGC's Criterion to grant autonomy to a college.
4. **So far as the accreditation by NAAC is concerned the institution has got accredited with Grade 'B'.**
5. **Implementation of academic and non-academic reforms:** So far as the academic reform is concerned the RUSA document emphasized upon the introduction of semester system at all levels of higher education based on experiences of Europe and America. The benefits of the system being enlarged curricula space, enhanced opportunities for learning etc. Since these reforms are beyond out jurisdiction as it is for the universities to respond to. We on our part are in a position to accommodate ourselves to the said system if need be. For the purpose of non-academic reform. The Scholarship program of the state government is a step in the right direction. It is aimed at enhancing the Gross Enrolment Ratio of the marginalized sections like SCs, STs, and OBCs. Apart from this very pious step the academic performance of the students from these sections also needs to be improved then only the sole aim of employability can be achieved. For this we can have extra remedial classes for such students who feel the need. Such steps would definitely increase the transition rate and pass rate of such students.

Certain skill development programs can also be organized to equip such students with the required necessities of competitive world. In this respect we may organize various tutorials for Maths, Reasoning, English, and General Studies etc. We can also have special personality enhancement programs aimed at improving the persona of the prospective professionals. See the importance and demand of the market we may also give special emphasis on English speaking course in our institution for such students apart from other students also. Such proposed steps would increase the employability of the students from underprivileged and marginalized sections of the society. As we are in a dire need of improving the skills of laboratory technicians and library staffs to prepare them work more efficiently. For implementing such nonacademic reforms, we may organize technical training programs for laboratory technicians at regular intervals. Library can also be trained so as to acquaint them with the niceties of book keeping and other library tasks.

6. **Improving interaction with industry:** Ours being a highly industrial area has more job opportunities for the youths of all the levels. Though we already have a placement cell yet we require improvement in interaction with industry for the purpose of generating more employment for our students passing out of UG and PG programs. Once we arrange for the required vocational courses along with UG and PG our students would be in a position to serve the industry in the desired way. We shall devise a plan for interaction of people from various industries and students from different curricula for the said purpose.
7. **Enhancement of research and consultancy activities:** As has already been proposed to open certain new research centers in the required field of studies. We would plan to enhance activities of the research scholars in the field of Seminars and Workshops to enhance their skills. We would encourage them to

contribute in the area of writing Articles and research related publications in various renowned national and international refereed journals. For the advanced research work we would propose to enrich our libraries with latest and required reference books of importance. We would also advise and encourage the research scholars to take up various needful and purposeful empirical tasks as a part of their research work.

We are also having a very meaningful and necessary plan to open Legal Aid and Human Rights Cell as a part of our existing Law Faculty to serve the needy of the region. With these two we may run consultancy programs for those who need the required counselling. Those who will serve these in extra hours may be provided with certain extra remuneration for the service.

8. The Scholarship program of the state government is a step in the right direction. It is aimed at enhancing the Gross Enrolment Ratio of the marginalized sections like SCs, STs, and OBCs. Apart from this very pious step the academic performance of the students from these sections also needs to be improved then only the sole aim of employability can be achieved. For this we can have extra remedial classes for such students who feel the need. Such steps would definitely increase the transition rate and pass rate of such students.

Certain skill development programs can also be organized to equip such students with the required necessities of competitive world. In this respect we may organize various tutorials for Mathematics, Reasoning, English, and General Studies etc. We can also have special personality enhancement programs aimed at improving the persona of the prospective professionals. See the importance and demand of the market we may also give special emphasis on English speaking course in our institution for such students apart from other students also. Such proposed steps would increase the employability of the students from underprivileged and marginalized sections of the society.

9. For the purpose of strengthening of existing PG program we are very much in the need of required faculty members for which various posts are still lying vacant. We are short of required number of laboratory technicians and laboratory assistants in some of the departments. We require more up to date and well-furnished laboratories in almost all the departments of Faculty of Science. We are proposing to open certain necessary courses at PG level for which the desirous students have to go to distant places. Such PG courses are MSc in, MA in Geography, Home Science and Sanskrit.
10. Summary of Training Needs Analysis: While analyzing the training needs of our faculty we have come across the fact that most of the teachers are in the habit of teaching in their very traditional way which lacks latest knowledge and current advanced ways of teaching. They are even lacking in the various research methodology which are now part and parcel of the new curricula for research made mandatory by the UGC. Some of the faculty members are even lacking in advanced qualifications like Ph.D. They are less desirous of taking part in Seminars and Workshops of importance.
11. Faculty Development Plan for 18 months: Based on the above made training needs analysis a Faculty Development Plan has been made. The traditional style of teaching is to be honed with the substitution of advanced pedagogy. Teachers should be acquainted with the standard ways of teaching methods having far reaching impact on the learning ability of the students. With the passage of time new developments are imminent in almost all the fields of study. Therefore, it is a must for the teachers involved especially in higher education to keep themselves up to date and aware of all the latest developments. For this purpose, we may organize teacher training programs at certain intervals. Since the area of research is to be especially taken care of for bringing our institution at par with other institutions of excellence, therefore we may propose to conduct training programs for our teachers of various faculties to hone their skills in the field of conducting research. They are also needed to be acquainted with the latest research methodology which has now become necessary for newly enrolled research scholars by the UGC. In this way we can develop our faculty and prepare them for ushering into the new era of academic excellence consequently improving the employability of our students.
12. Action Plan for training technical and other staff in functional areas: So far as advancement in the workability of the technical staffs is concerned, we are proposing to conduct technical training programs at certain intervals for our laboratory technicians and laboratory assistant. With the establishment of computer lab, we will also be in a position to conduct training program for improving their computer skills. Other staffs of the institution may also be trained in the required field of computer skills. They may also be trained or acquainted with the knowledge of accountancy and latest rules and regulations and even the legislations enacted by the state legislature and the union parliament for academic purposes.

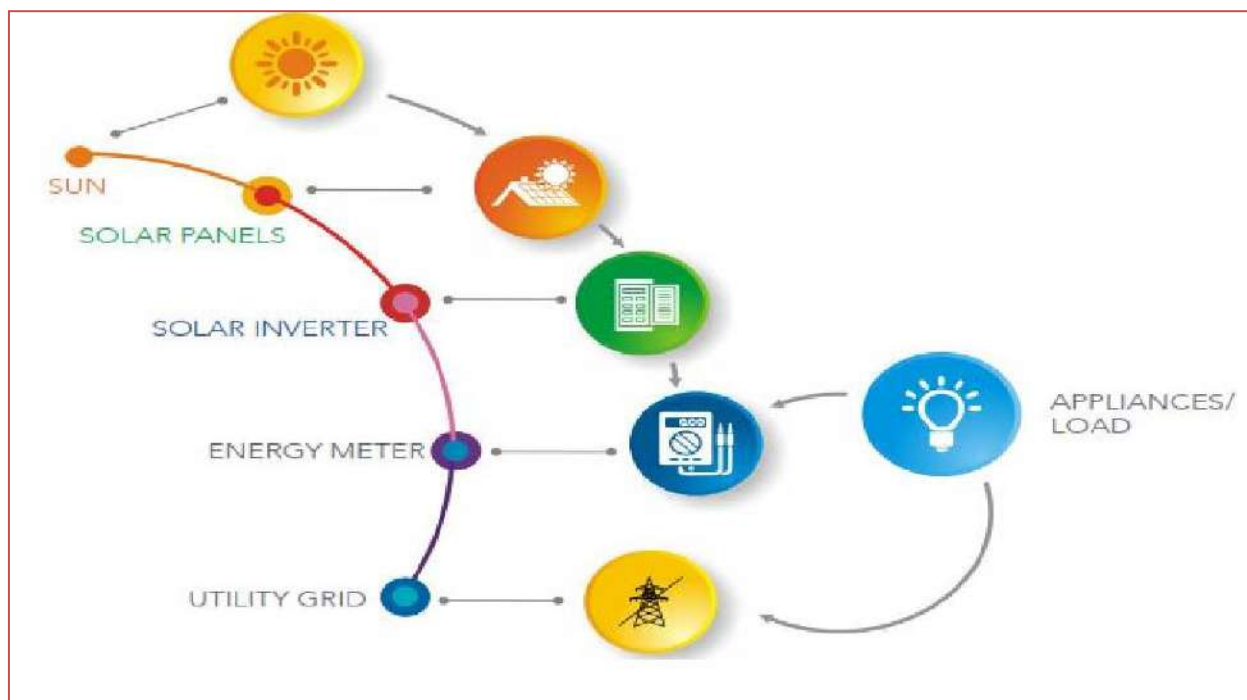

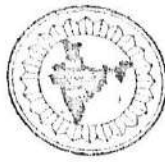

Certain show cause notices had also been issued specifically to certain Centers of Legal Education/Colleges, with conditions mentioned therein to be complied with.

The time for compliance of the circular and the show causes was extended till 31st October, 2020 by virtue of the resolution passed on 24th June, 2020 by the Bar Council of India. Further by virtue of the resolution in the meetings of 9th, 10, and 11th of November, 2020 the Standing Committee of Legal Education Committee of the Bar Council of India has considered the requests received from many quarters to further extend such date and owing to the prevalency of the pandemic has decided to further extend the date for compliance of the circular of 5th February, 2020, and of the show causes/compliance letters till 28 February, 2021



It is made clear that if any Center of Legal Education, fails to submit all the required documents as sought by way of the referred circular and the show cause notices (where applicable), already issued, and the subsequent circular to be issued in this regard, on or before 28th February, 2021, including certified authenticated bank statements, library receipts and faculty list with qualifications then their application for extension of approval for 2021-22 shall not be considered and/or approval already granted may be withdrawn.

You may kindly bear in mind that the Bar Council of India is the sole and supreme sanctioning authority for seats and as a general rule it does not allow any supernumerary quota of seats for law degree courses, over and above the sanctioned strength of seats and whatever reservation of seats is to be done by the University as a general rule has to be done within sanctioned strength of seats.

The Center/s of Legal Education/College may take a note of the above mentioned facts and furnish compliance of the same and of the other rules and regulations of Legal Education, including the stipulations specified in the abovesaid referred circular/s, show cause notices and compliance letters, and in Annexure A, attached to this provisional approval of affiliation letter, which is required to be complied with by/on/before 28.02.2020 with adequate documentary proof and by way of a notarized affidavit, failing which as stated above their application for extension of approval for 2021-2022 shall not be considered and/or approval already granted may be withdrawn.

Since your university has given affiliation from the year 2014-2015 to 2020-21, You are requested to allow **Govt. T C. L.P.G. College, Janjgir, Bilaspur, Chattisgarh** to admit students in **three year law course** with prevalent/ existing sections from the academic year 2013-2014 to 2020-2021.

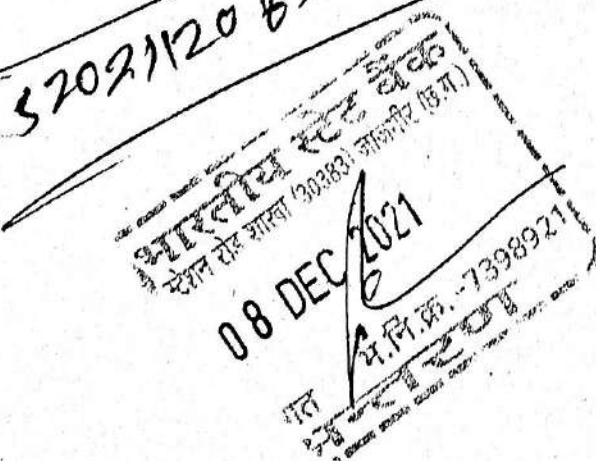
